Subject: Compliance with Delhi Pharmacy Council Directions

Dear Members,

This is to inform all pharmacy owners, chemists and druggists in Delhi that the Delhi Pharmacy Council, vide its Notice No. DPC/2025/924 dated 14.10.2025, has reiterated that dispensing of medicines can only be done by a Registered Pharmacist under Section 42 of the Pharmacy Act, 1948.

Any person other than a Registered Pharmacist is not permitted to compound, prepare, mix, or dispense any medicine on prescription.

Further, under the amended provisions of the Pharmacy Act, 1948 (as per the Jan Vishwas Amendment of Provisions Act, 2023), violations will now attract enhanced penalties, including:


- Imprisonment up to six months, or
- Fine up to ₹1,00,000, or both.

All members are therefore strictly advised to ensure full compliance with the Act and maintain a Registered Pharmacist on duty during pharmacy hours.

Failure to comply may lead to suspension or cancellation of registration by the Delhi Pharmacy Council.

RDCA Delhi urges all its members to act responsibly and uphold the law — for the dignity of our profession and protection of the chemist fraternity.
